### CALL TO ORDER

### **APPROVAL OF MINUTES**

#### **REPORT OF THE DIRECTOR**

Scott Schoolcraft presented a written report.

#### PUBLIC HEARING

Motion to open the 2022 General Appropriation Act (budget) hearing by Thad Beard, second by Greg Madura. Motion approved unanimously. No comments. Motion to close the 2022 budget hearing by Greg Madura, second by Thad Beard. Motion approved unanimously.

#### OLD BUSINESS

A. Motion by Thad Beard, second by Greg Madura to approve Resolution 2021-02 adopting the 2022 budget. Roll call vote: Terry Bartels; aye, Greg Madura; aye, Thad Beard; aye, Cameron VanWyngarden; aye.

B. Century A&E provided an analysis of the roof failure in the Machine Building. Century A&E concurred that the roof failure was caused by a combination of vapor drive withing the building, and movement of the metal roofing. A full replacement of the roof is recommended.

Motion by Thad Beard, second by Greg Madura to approve the proposal submitted by Prein and Newhof to assist with specified design and the bidding process for the roof replacement on the Machine Building. Cost of proposal not to exceed \$25,000.00. All ayes, motion approved unanimously.

C. It was determined that a solar farm would have to be located off site. The NKSA board paused the project for an indeterminate amount of time. The project will be re-examined should it become feasible.
